## COVENANT FOR A RESTRICTED USE AREA REGARDING CERTIFIED POOL/SPA FILL

Pursuant to Section 110 of the County of Los Angeles Building Code, Title 26, the defined area as shown on the attached exhibit is recorded as a "RESTRICTED USE AREA". RESTRICTED USE AREA shall mean an area that is required to remain free and clear of any permanent residential structure unless approved by the Building Official. The purpose of which is to identify uncertified pads and grading on the property preventing the construction of a residential building and/or structural supporting structure in an area that was previously developed as a swimming pool and/or similar landscape feature requiring soil excavation that has since been demolished and backfilled with soil that does not meet the minimum requirement for compaction. Accordingly, should the property owner wish to construct a permanent residential building and/or structural supporting within the RESTRICTED USE AREA, a California State-licensed Civil Engineer shall be required to certify that said area satisfies the minimum soil compaction levels for construction as established by the Building Code.
